Notes of the Parish Council meeting held on Monday 5th June 2023 at 6.30pm at Skillington Village Hall.

Present: Cllr R. Wrigley (Chair), Cllrs N. Clark, R. McKee and B. Hedley.

In Attendance: Cllr D. Bellamy (SKDC), Cllr C. Vernon (LCC), D. Beecher (resident).

The meeting began with a ten-minute Open Forum. Mr Beecher asked again if the Chair contacted Ian Simmonds, SKDC Community Protection Officer 'as an individual' or on behalf of and having consulted the Parish Council. He also objected to the use of the words 'dangerous dog' in Parish Council Minutes (February 2023, item 11.4) about his dog. The Chair confirmed he would respond in writing.

1. **Apologies for absence:** Cllrs Burrows and Grindey, Cllr B. Green (SKDC), Mrs P. Harrison (Clerk).
2. **Councillors' Declaration of Interest:** None.
3. **Notes of meeting of the Parish Council on 10th May 2023:** Agreed and signed into minutes.
4. **Matters arising from the minutes:**
 - 4.1 04.23/11.1 Cllr Hedley has conducted the Clerk's appraisal. An increase in quarterly running costs from £20 to £30 was proposed and agreed. It was also agreed that henceforth appraisals will take place every two years; but in years where there is no formal appraisal, the Clerk will meet with the Chair to allow issues to be raised.

- 9.1 Speed limit sign on Stonepit Lane. A sign requesting careful, slow driving has been put up at entrance to Stonepit Lane by a local resident.
- 9.2 Future PC meeting venue. The Chair noted problems accessing the Village Hall because of key availability, and suggested consideration of the Chapel as an alternative. Opinion was divided but we will remain at the VH until further notice.

10. District and County Councillor's Reports: Cllr Bellamy reported on the post-election situation at SKDC. Cllr Vernon drew attention to volunteering possibilities, and the County Views survey.**11. Any matters arising at the discretion of the Chairman:**

- 11.1 Large quantities of straw on village roads from waggons moving this from Saltby airfield. Cllr Clark provided contact details. Cllr Vernon noted this had been raised by several local villages affected by the same problem. The lorries carrying straw are not required to be covered.
